

Cuba



MANDATE

HI aims to encourage initiatives aiming to build a more inclusive society by relying on and reinforcing the existing expertise, social structure and political will in favor of people with disabilities in Cuba.

SITUATION

The Republic of Cuba is the biggest country in the Caribbean, with more than 11 million inhabitants. According to the most recent census conducted by the Cuban government, there are more than 360,000 people with disabilities (PWD) in Cuba that is 3.26% of the population. 38% of people with disabilities suffer from a mental impairment and 25.22% from a physical or motor disability. Since 2011, the country has led a process of updating its socio-economic system and in 2015, Presidents Barack Obama and Raul Castro announced the restoration of dialogue between the two countries, after more than 50 years of absence. Despite people with disabilities' access, after more than 50 years of absence Despite people with and the staff is highly qualified), difficult transportation conditions and the lack of modern and/or specialised equipment (such as audiometry tests) limit this access. The island of Cuba is particularly prone to hurricanes which cause regular and serious economic damage to the country and worsen the living conditions of the population, particularly the most vulnerable people.

INITIAL ACTIONS

Since 1998, HI has been implementing project with national partners (ministries and disabled people's organizations) through multisector steering committees which generate constant dialogue and a climate of trust with the partners. This legitimacy allowed HI to successfully develop the following projects: support to a prostheses and orthotics production center (in 1998), community based rehabilitation projects in the provinces of Granma, Pinard el Rio and Holguin (since 2001), inclusive education projects in rural and urban areas (2007), support to the three national disabled people's organizations (2008) a socio-economic inclusion project (since 2014) and an inclusive disaster risk management project in partnership with Oxfam and care NGOs.

Community-based rehabilitation

GOAL

Improving the prevention, case-management and understanding of severe intellectual disabilities in the community. HI works with people with disabilities, their communities, representatives of organisations, and in conjunction with institutions working in the field of rehabilitation.

METHOD

In Cuba, more than 38% of people with disabilities have an intellectual disability (and 17% have a severe and profound intellectual disability). This particularly high prevalence rate is due to several factors: a lack of information on the risk of children developing disabilities during pregnancy, a shortage of specialist medical equipment, poor guidance and preparation for families with disabled children, and the absence of a national integrated community-based rehabilitation model. This community-based rehabilitation project run by HI aims to support people with disabilities in Pinar Del Rio province.

BENEFICIARIES

Direct beneficiaries:

- 375 people aged under thirty, with a severe and profound intellectual disability, living in one of five municipalities in the province of Pinard el Rio
- 817 professionals (obstetricians, family doctors, paediatricians, psychiatrists, nurses, multi-disciplinary teams, etc.)

Indirect beneficiaries:

1071 people with a severe and profound intellectual disability

PARTNERS

- The medical genetics centre, provincial and community network. This centre is tasked with:
 - preventing and diagnosing severe and profound intellectual disability
 - training medical staff in disability risk factors during pregnancy and childbirth
 - o organising prevention awareness-raising campaigns
 - o providing community-based and psychoeducational support to families

Socio-economic inclusion

GOAL

Helping people with disabilities in the province of Granma to find a job appropriate to their skills, desires and the needs of their community.

METHOD

This project, which is based on the CBR process is implemented in Granma and aims to promote social and economic inclusion¹ of people with disabilities to integrate in their community and gain access to a job, through processes of rehabilitation, training, strengthening of self-esteem, and economic assessment. The beneficiaries are accompanied individually and supported by community advisors. HI also aims to strengthen vocational trainings structures.

BENEFICIARIES

Direct:

- 2,370 people with disabilities:
 - o 600 beneficiaries of a personalised inclusive employment plan
 - 400 beneficiaries (among them 160 are young people) of training in 57 new professional training areas (49 are specific and trade schools)
 - o 277 people with disabilities benefiting from 226 tool modules for micro businesses
 - o 350 beneficiaries in employment (salaried or self-employment)
 - 100 beneficiaries of jobs made available for people with disabilities
- 150 community officers
- 67 guidance officers
- 15 members of municipal rehabilitation committees

Indirect:

- 16,000 people with disabilities in the province
- 600 families of PWDs who have received training, and 400 families of PWDs in employment
- 146,000 beneficiaries of the awareness-raising campaign (unemployed PWDs in Cuba)
